#### I. CALL TO ORDER

Chairman Miller called the meeting to order at 3:00 PM.

#### **II. PLEDGE OF ALLEGIANCE**

Chairman Miller led the Management Committee, guests, and CAG staff in the Pledge of Allegiance.

#### IV. CALL TO THE PUBLIC

#### V. LEGISLATIVE UPDATE

No Legislative Update was provided.

#### VI. CONSENT ITEMS

Mr. Paul Jepson, City of Globe, made a motion to approve the consent agenda items as presented. Mr. Alexis Rivera, Town of Miami, seconded the motion. The motion passed unanimously.

#### A. Approval of the June 14, 2023 Management Committee Meeting Minutes

The June 14, 2023 Management Committee minutes were approved under Consent Agenda Item VI-A.

#### B. Approval of CAG's Committee Membership

The CAG Committee Memberships were approved under Consent Agenda Item VI-B.

#### VII. EXECUTIVE DIRECTOR'S REPORT

Ms. Andrea Robles updated the Committee on recent activities and meetings taking place at CAG. She stated that the Rural Transportation Summit would be held October 18-19<sup>th</sup> in Yuma and that the link to register had been sent out to members. Ms. Robles stated that staff attended a two-day grants management training in July. She stated that she along with staff also attended the Rural Policy Forum, Arizona Housing Forum and the League of Arizona Cities and Towns Conference. Ms. Robles stated that meetings have been held with the Gila County Manager and Gila County communities to discuss the next steps for the Gila County IPTA.

She stated that staff is currently working on getting the FY 22 CDBG projects funding and writing the applications for FY23. Ms. Robles informed the Committee that she and staff were invited to participate on the Governor's Task Force for Infrastructure and Jobs. She attended the first meeting in August and stated that she would provide updates from future meetings. Questions, comments, and discussion followed. This was an information item.

#### VIII. NEW BUSINESS

#### A. Confirmation of the Regional Council Voting Membership

Ms. Andrea Robles stated that this item is updated every year in September. She stated that an update is given at the Regional Council meeting in regards to who has paid their membership dues. Ms. Robles stated that membership dues are required to be paid by the meeting in November. She stated that as of now, most member dues have been paid with the exception of a couple of the tribal governments. Ms. Robles stated that second notices had been sent to those members. Mr. Rick Miller, City of Coolidge, asked if members fail to pay, will they be able to vote. Ms. Robles stated that the member will lose their voting privileges until the dues are paid. Mr. Paul Jepson, City of Globe, made a motion to approve and pass to Regional Council the confirmation of the Regional Council Voting Membership. Ms. Heather Wilkey, Town of Queen Creek, seconded the motion. The motion passed unanimously.

#### B. Financial Report

Ms. Yvonne Tackett presented the July 2023 Financial Report. She stated that with 8% of the new fiscal year completed, expenditures are at 3.11% and revenues are 22.10% of the anticipated annual revenues. She stated that the expenditures are low due to one payroll and some invoices being accrued back to FY 23. She stated that expenditures were 94.95% and revenues were 92.87% leaving a net figure of \$1,936. Ms. Tackett stated that she had included a funding sources page to keep the committee informed of when our grants and funds come into CAG. She stated that new contracts will be added and the membership dues are not included in this sheet. Questions, comments, and discussion followed. Mr. Alexis Rivera, Town of Miami, made a motion to approve and pass to Regional Council the July 2023 Financial Report as presented. Mr. David Malewitz, City of Eloy, seconded the motion. The motion passed unanimously.

#### C. CAG FY 2024 – FY 2029 Transportation Improvement Program (TIP)

Mr. Travis Ashbaugh presented the CAG FY 2024 – FY 2029 Transportation Improvement Program amendments. He stated that there are eight TIP amendments for recommendation. Mr. Ashbaugh stated that one is being removed as it was funded under the FY 24 RTAC initiative, four are being removed due to completion, and three are being advanced three to four years ahead of where they were projected due to the project that was funded through the RTAC initiative. Questions, comments, and discussion followed. Mr. Paul Jepson, City of Globe, made a motion to approve and pass to Regional Council the CAG FY 2024 – FY 2029 TIP amendments as presented. Mr. Alexis Rivera, Town of Miami, seconded the motion. The motion passed unanimously.

#### D. CAG/SCMPO Joint Project Agreement (JPA) for Mobility Management Services

Mr. Travis Ashbaugh informed the committee that the JPA agreement that CAG has with the Sun Corridor MPO to provide Mobility Management services in their region is an agreement that comes to the committee annually for approval before the new federal fiscal year begins. Questions, comments, and discussion followed. Ms. Heather Wilkey, Town of Queen Creek, made a motion to approve and pass to Regional Council the CAG/SCMPO Joint Project Agreement (JPA) for Mobility Management Services as presented. Mr. Alexis Rivera, Town of Miami, seconded the motion. The motion passed unanimously.

#### E. Authorization to apply for the 5310 Grant Application

Mr. Travis Ashbaugh informed the committee that every two years CAG applies for the 5310 Grant for Mobility Management services. He stated that part of the application is to receive authorization from the Regional Council to apply for the grant. Questions, comments, and discussion followed. Mr. Alexis Rivera, Town of Miami, made a motion to approve and pass to the Regional Council the authorization for CAG to apply for the 5310 Grant. Mr. Mackenzie Letcher, City of Casa Grande, seconded the motion. The motion passed unanimously.

#### F. FY 2025 Rural Transportation Advocacy Council (RTAC) Priority Project List

Mr. Travis Ashbaugh presented the FY 2025 Rural Transportation Advocacy Council (RTAC) Priority Project List. He stated that in the Fiscal Year 2024 State Budget there was a decent amount of funding that was allocated to the projects that were submitted to last years RTAC initiative. Mr. Ashbaugh stated that 79% of the funds requested were awarded. He stated that the RTAC Board has decided to go after another package in the FY 2025 State Budget cycle, in the amount of \$400 million for projects and an additional \$100 million from the SMART fund. Mr. Ashbaugh stated that the \$400 million is broken down by population within each COG and MPO so CAG's portion of that would be approximately \$20 million. He stated that the same planning process was used as last year.

Mr. Ashbaugh stated that ten projects were submitted and nine of those projects are being advanced for consideration. He stated that the projects, ranked in order of priority, are Globe: Yuma Street Bridge design and construction (\$2,989,777.16); Winkelman/Hayden: Quarelli Street & Golf Course Road Phase 2 design and construction (\$2,166,375.69); Payson: McLane Road design and construction (\$3,406,785.69); Star Valley: Local Street Improvements design and construction (\$2,301,411.69); Superior: Lobb/Neary/Kellner Road Improvements construction only (\$1,528,467.69); Gila County: Young Road (NFSR 512) design and construction (\$1,796,785.69); Pinal County: Calle Futura Street & Neal Street Improvements construction only (\$1,081,23.69); Pinal County: McNab Parkway construction only (\$2,439,155.69); and Miami: Bridge & Local Street Improvements design and construction (\$2,321,935.69).

Mr. Ashbaugh stated that the projects are in order of priority and encouraged members to get in front of their Legislators to explain their need for the project. He stated that fact sheets are being developed and will be handed out to the legislators, similar to last year. Mr. Rick Miller, City of Coolidge, asked what the tenth project that was not selected for funding. Mr. Ashbaugh stated that the project was a third project submitted by Pinal County, which would cost more than the allotted funding, therefore Pinal County withdrew their project. Questions, comments, and discussion followed. Mr. Alexis Rivera, Town of Miami, made a motion to approve the FY 2025 Rural Transportation Advocacy Council Priority Project List as presented. Mr. David Malewitz, City of Eloy, seconded the motion. The motion passed unanimously.

#### IX. INFORMATION ITEMS

#### A. Department Updates

#### **Economic Development**

Ms. Stephanie Maack stated that staff is in the process of completing the six-month EDA progress report. She stated that staff attended the Town of Star Valley Town Council meeting to provide a CAG 101 presentation, meetings with the Town of Hayden, Town of Kearny and Town of Winkelman to discuss blight solutions, ongoing economic development efforts, and to see where CAG can assist them with community development and business development. Ms. Maack stated that she attended the Arizona Rural Policy and is preparing for the AAED fall forum.

She stated that she and Ms. Robles attended the Task Force for Infrastructure and Jobs. Ms. Maack stated that this task force has been meeting since early 2022 and is focused on identifying grant opportunities and supporting projects that address broadband, workforce development, cyber security, health issues and energy. Questions, comments, and discussion followed. This was an information item.

#### **Planning Department**

Ms. Angela Gotto stated that CAG is currently providing administration and Davis-Bacon labor standards monitoring for 13 active WIFA projects throughout the CAG Region. She stated that a site visit to conduct interviews was completed for the City of Eloy's WIFA project and everything is being completed on schedule. Ms. Gotto stated that there are several WIFA projects that are about to start or resume in the next couple of months. She stated that residential completion data was due back to CAG on September 8<sup>th</sup> and that she is working with one of the member agencies who has not submitted their data. Ms. Gotto stated that the final documents are being prepared to execute the annual contract with MAG for the update and development of the CAG area data and forecast services in Pinal County. Questions, comments, and discussion followed. This was an information item.

#### Community Development Block Grant (CDBG)

Ms. Angela Gotto stated that the FY 23 applications for Star Valley, Superior and Winkelman have been submitted. She stated that CAG will be providing project administration on all three of those projects. Ms. Gotto stated that the environmental reviews are in progress for all three communities. She stated that staff is currently assisting Gila County with their public participation. Ms. Gotto stated that the bid documents for the Town of Kearny's Hubbard Park Improvements project were approved by ADOH and sent out to contractors. She stated that the Town of Hayden's Wastewater Treatment Plant Improvements Project is nearing completion. Ms. Gotto stated that the City of Globe Veteran's Park Project will be complete at the end of the month, when the park benches are installed. Questions, comments, and discussion followed. This was an information item.

#### **Transportation Department**

Mr. Travis Ashbaugh stated that the traffic counts program is nearly completed. He stated that there were 13 locations that needed to be counted and approximately 28 that needed to be recounted. He stated this would complete this item for calendar year 2023. Mr. Ashbaugh stated that the Gila County Intergovernmental Public Transportation Agency (IPTA) was officially formed on May 9, 2023. He stated that staff is currently working on a plan for the transition from the 5311 program to the Gila County IPTA. Mr. Ashbaugh stated that AECOM may continue as the interim manager to assist with that transition so that the IPTA can be a grant applicant in the next cycle. He stated that he and Ms. Robles will be reviewing AECOM's proposal and discussing the next steps with Gila County.

Mr. Ashbaugh stated that proposals for the Pinal County Mobility Gap Analysis were due on September 13<sup>th</sup> and that he had received two proposals. He stated that the selection committee will be reviewing the proposals and ranking them. Mr. Ashbaugh stated that the consultant should be selected and under contract by November. Questions, comments, and discussion followed. This was an information item.

#### Water Quality Planning

Mr. Travis Ashbaugh stated that the review of the City of Coolidge's Draft 208 Plan Amendment has been completed. He stated that it has been returned to Coolidge for revisions and once he receives the revisions, he will complete the second review. Mr. Ashbaugh stated that the Tri City Sanitary District will be having a stakeholder meeting on October 10<sup>th</sup> to work out issues with stakeholders. He stated Mountain Pass Utility Company has submitted their first draft and will begin their review. Mr. Ashbaugh stated that the Neon Ranch project is on hold at this time but is expected to reconvene within the year. He stated that the City of Casa Grande is expected to submit a plan as well. Mr. Ashbaugh stated that the Pinal County Septic Use Study should be completed by the end of the year and a report will be produced like what was done for the Gila County Septic Use Study. Questions, comments, and discussion followed. This was an information item.

Continue to revisit leases for equipment and operational expenses, resulting in savings to the agency.

Held open enrollment for staff medical benefits. CAG once again received a decrease in employee benefits costs.

Staff assisted the Town of Kearny with an application for a Brownfields Grant to remediate their library.

Attended the Roads and Streets Conference held in Tucson November 1-3, 2023.

The North-South Corridor has been the focus of many stakeholders over the past several years including CAG. On November 7, 2023, the ADOT Route Number Committee convened to select a route number for the highly anticipated corridor. With CAG's participation and input, the Committee recommended the planning designation of the North-South corridor from Interstate 10 to US 60, as

State Route 505. The Arizona Transportation Board approved the recommendation on December 15, 2023.

Attended a COG/MPO partnering workshop with ADOT. This was an opportunity to discuss with the ADOT Director and lead staff what is working and challenges amongst program/grants.

Attended the State Transportation Board Breakfast and Meeting in Maricopa.

#### <u>PRTA</u>

### TITLE VI OF THE CIVIL RIGHTS ACT OF 1964

### What is the Law?



"No person in the United States shall, on the grounds of race, color, and/or national origin, be excluded from the participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity receiving Federal financial assistance." – Title VI of the Civil Rights Act of 1964; 42 U.S.C. § 2000d, et seq.



### DISCRIMINATION

That **act** (action or inaction), whether intentional or unintentional, through which a person in the United States solely because of their <u>race</u>, <u>color</u>, <u>national origin</u>, etc. is subjected to **disparate [unequal] treatment** or **impact**, in any program or activity receiving financial assistance from Federal Highway Administration (FHWA) under 23 U.S.C.

## What is a DBE?



#### **Disadvantage Business Enterprise (DBE):**

A for-profit small business that:

### **Summary Discussion**

The purpose of the CAG/Sun Corridor Metropolitan Planning Organization (MPO) Human Services Transportation Coordination Plan (HSTCP) is to identify the transportation needs of individuals with disabilities, older adults, and people with low incomes, provide strategies from meeting these needs and prioritize transportation services for funding and implementation. For providers to be eligible for 5310 Transit grant funding, their requests must be included within the current update. CAG and the Sun Corridor MPO utilizes a process that includes representatives of public, private and nonprofit transportation, and human service providers, elected officials and public participation to identify transit needs/service gaps and to establish priorities in order to make informative funding decisions for specialized transportation services.

CAG and the Sun Corridor MPO, under a Joint Planning Agreement, have come together and recognized that the transit environment is dynamic and dependent on stakeholder involvement. As a result, CAG and the Sun Corridor MPO review and update the CAG/Sun Corridor MPO HSTCP annually in order to capture annual adjustments. The update includes updated demographic information as well as the status of new and existing transportation providers serving the transportation dependent and disadvantaged populations in the Region.

# **Fiscal Impacts**

Failure to approve the plan may result in a loss of funding (\$110,000) that provides mobility management coordination to the CAG and Sun corridor MPO Regions.

# Economic Development – Stephanie Maack

- Staff attended the construction groundbreaking ceremony for the Hill Street School Senior Housing Complex and attended the State of the City address for the City of Globe on September 28, 2023.
- Staff attended monthly AAED (Arizona Association for Economic Development) committee meetings.
- CEDS Committee Meeting was held on October 12, 2023.
- A Resiliency and Social Media Workshop was held on October 24, 2023, at the City of Coolidge Chambers in collaboration with the Coolidge and Greater Florence Chambers of Commerce.
- Staff attended the AAED (Arizona Association for Economic Development) Fall Forum that was held October 25th 27<sup>th</sup>, 2023 in Flagstaff. Ms. Maack is the Vice-Chair of the committee. The focus on the Fall Forum is primarily rural development.
- Completed the Town of Kearny Public Library AQED Brownfield Grant. The grant was awarded by ADEQ to the Town of Kearny.
- Staff attended the Gila County Economic Development Steering Committee Meeting on November 5, 2023.
- Staff attended the Coolidge Economic Development Committee Meeting on November 9, 2023.
- Discussions have continued with Ecostrat regarding the Bioeconomy Development Opportunity (BDO) Zone designation.
- CEDS Committee Meeting was held on January 4, 2024.

# Community Development Block Grant - Angela Gotto

- The communities who receive FY 23 CDBG Funds (Star Valley, Superior and Winkelman) have all been funded and the environmental reviews have been approved.
- The Town of Superior (Lime Street Improvements) invitation to bid was published in the paper and sent out to consultants on January 10<sup>th</sup>. Bids are due by February 15<sup>th</sup> at 2:00 PM
- The Town of Miami (Historic Keystone Stairs Rehabilitation) has an engineering request for qualifications out. The RFQ's are due January 16<sup>th</sup> at 2:00 PM.
- The Town of Kearny (Hubbard Park Improvements) has selected Arizona Design and Construction for their project and will be under contract this month.
- The City of Globe and Town of Hayden FY 21 projects have been completed and closed out.
- We are working to schedule meetings with the communities that will receive FY 24 CDBG funding (Globe, Hayden, Apache Junction, Coolidge) to discuss preliminary project concept and public participation preparation.

# Planning Department

- We will be starting another round of data collection in January or February for the 3<sup>rd</sup> and 4<sup>th</sup> quarter 2023 residential completions to report to the state demographer's office for the development of annual population estimates.
- We have executed a contract with MAG for the update and development of the CAG area data and forecast services in Pinal County. This includes data collection for land use, traffic counts, existing and future network reviews, and population data. Staff will be reaching out to schedule reviews with the Pinal County member entities as needed.

# Transportation Department – Travis Ashbaugh

- The CY2024 Traffic Counts has begun and will continue through March 2024. The seventeen 7-day "growth counts" are the only traffic counts scheduled for CY2024.
- The first Gila County Intergovernmental Public Transportation Agency (GCIPTA) is in the works of being scheduled.
- The "Pinal County Coordinated Mobility Gap Analysis" will begin soon. AECOM was awarded the contract.

# Water Quality Planning – Travis Ashbaugh

- 208 Plan Amendments with Active Status:
  - City of Coolidge Public Hearing is scheduled for January 30, 2024.
  - Tri-City Regional Sanitary District Currently in the CAG 208 Plan Amendment Appeals Process.
